The 88-MW Mount Coffee hydropower plant in Liberia has gone into operation after extensive modernization, with startup of the first turbine-generator unit celebrated Dec. 15.. According to a press release from Voith, Liberia's President Ellen Johnson Sirleaf and 300 international guests were present at the celebration.

To overcome these challenges, Liberia has been exploring alternative solutions to reduce its dependency on imported fuels for thermal power generation. One strategy is to diversify the energy mix by increasing the share of domestic renewable energy sources, such as solar and wind power, for electricity generation.
