The Federal Energy Regulatory Commission (FERC) has approved Kinder Morgan's Gulf LNG expansion project in Jackson County, Mississippi. The proposed project would add 11.5 million tonnes of new capacity to Kinder Morgan's terminal in Pascagoula, which would include two liquefaction plants.

Today, that capacity has more than tripled, and the U.S. is the world"s largest LNG exporter with capacity set to nearly double by 2030 because of additional projects currently under construction. Cumulative approved exports are at 48 Bcf/d, over three times our current export capacity. A lot has changed since 2018.

By the end of 2028, the world"s total nameplate liquefaction capacity could reach 666.5 MTPA. For perspective, the International Energy Agency (IEA) projects total LNG trade in 2050 to reach 482 MTPA under its stated policies scenario. In other words, LNG liquefaction capacity coming online through 2028 exceeds IEA long-term demand scenarios.

The project received approval from the US Department of Energy (DOE) to ship LNG to the countries that are part of Free-Trade Agreement (FTA) in September 2016. NextDecade signed a 30-year lease agreement with the Brownsville Navigation District for a 398ha site at the Port of Brownsville, in March 2019.
