The environmental subsidies were presented by alderman Patrick Goldschmidt, a member of the Municipal Executive Board from the Democratic Party (DP). If a request for energy renovations is granted at the national level, the municipality of Luxembourg City will provide a subsidy equal to 50% of the amount of the state aid.

The government will subsidize up to 60% of the cost of installing a residential energy storage system, with a maximum subsidy of 50,000 kroner or \$5,600. The announcement follows the country's plans to stop burning fossil fuels to make electricity by the year 2040.

For new energy storage stations with an installed capacity of 1 MW and above, a subsidy of no more than 0.3 yuan/kWh will be given to investors based on the amount of discharge electricity from the next month after grid connection and operation, and the subsidy will not last for more than 2 years.

Luxembourg aims to cover over a third of 2030 electricity demand with renewables, mostly through variable renewable energy (VRE) from PV and wind generation. The share of VRE generation in imported electricity is also expected to increase significantly. Taken together, these factors will require substantial investment in electricity infrastructure.

At the same time, financing opportunities and subsidies need to be developed, such as: o Capacity mechanisms for energy storage facilities; o Extension of already-existing subsidies for prosumers to include storage installations; o Support schemes for off-grid solutions that incorporate storage;

At the beginning of the year, all renovation subsidies were increased to a maximum of 62.5% of the costs excluding VAT (previously the limit was 50% of the costs excluding VAT). The only exceptions to this are subsidies for energy consulting and support for individual renovation measures, which remain unchanged.

The nearly 50GW of battery storage that could be online by 2037 will increase the wholesale market revenues for wind and solar assets and thereby reduce the amount of subsidies payed to those assets out of general taxation through the EEG (Erneuerbare-Energien-Gesetz/Renewable Energy Sources Act) scheme, which is similar to the UK''s contracts for ...
