Under the direction of the national "Guiding Opinions on Promoting Energy Storage Technology and Industry Development" policy, the development of energy storage in China over the past five years has entered the fast track.

In January 2022, the National Development and Reform Commission and the National Energy Administration jointly issued the Implementation Plan for the Development of New Energy Storage during the 14th Five-Year Plan Period, emphasizing the fundamental role of new energy storage technologies in a new power system.
