The DOE has recently issued a document, Grid Energy Storage, 1. which lays out its strategy and plans for energy storage. This strategy document is intended as a complementary document to the DOE document that addresses additional policy issues at a national level. Specific storage

energy storage projects, which make up 34% of the current projects in the connections queue. To deliver this, we have improved our modelling assumptions to better reflect the system impact of battery energy storage systems (BESS). States have also focused on removing regulatory barriers to adopting energy storage by requiring or authorizing utilities to consider energy storage in resource planning and by creating standards for connecting storage resources to the grid.

The report highlights best practices, identifies barriers, and underscores the urgent need to expand state energy storage policymaking to support decarbonization in the US. This report and webinar were developed on behalf of the Energy Storage Technology Advancement Partnership (ESTAP).

Yet the most effective approaches to energy storage policymaking are far from clear. This report, published jointly by Sandia National Laboratories and the Clean Energy States Alliance, summarizes findings from a 2022 survey of states leading in decarbonization goals and programs.

The Energy Storage Obligation (ESO) specifies that the percentage of total energy consumed from solar and/or wind, with or through energy storage should be set at 1% in the 2023-2024 timeframe and gradually rise to 4% by 2029-2030, as in the table below.

The backlog of new power generation and energy storage seeking transmission connections across the U.S. grew again in 2023, with nearly 2,600 gigawatts (GW) of generation and storage capacity now actively seeking grid interconnection, according to new research from Lawrence Berkeley National Laboratory (Berkeley Lab).

In 2020-2021, in response to the COVID 19 pandemic, Saudi Arabia has committed at least USD 6.50 billion to supporting different energy types through new or amended policies, according to official government sources and other publicly available information. These public money commitments include: At least USD 5.59 billion for unconditional fossil fuels through 5 policies ...

On November 27, the National Energy Administration released its No. 5 announcement for 2020, approving 502 energy industry standards. Seven of the announced standards relate to energy storage, covering areas including supercapacitors for electric energy storage, code specifications for traceability of electrochemical energy storage systems, design ...

As the report details, energy storage is a key component in making renewable energy sources, like wind and solar, financially and logistically viable at the scales needed to decarbonize our power grid and combat climate change.

On October 11, 2017, China released its first national-level guiding-policy document covering energy storage. The document, "Guiding Opinions on Promoting Energy Storage Technology and Industry Development" (hereafter referred to as "Guiding Opinions") marks a significant milestone, providing a unified framework for subsequent policies and detailing key development tasks.

In its draft national electricity plan, released in September 2022, India has included ambitious targets for the development of battery energy storage. In March 2023, the European Commission published a series of recommendations on policy actions to support greater deployment of electricity storage in the European Union

The government of Morocco started the implementation of its National Energy Strategy in 2009. The Morocco Energy Policy MRV analysis shows that energy subsidies reform and renewable policies to date, resulted in the reduction of 5.6 million metric tons of carbon dioxide (MtCO<sub>2</sub>) during the 2009-2016 period relative to the baseline.

The 878 MWh of new energy capacity brings installed energy capacity to 9.5 GWh. Amazingly, over August and September of 2024, nearly 2 GWh of capacity was approved for commercial operations. The six new battery energy storage systems are distributed across the state - and three of them are owned by ENGIE.
