It has successfully guided our energy sector for almost twenty years now. However, Namibia is rapidly changing, and so is the world around us.

In a lead carbon battery, the negative electrode is made of pure lead while the positive electrode is made up of a mixture of lead oxide and activated carbon. When the battery discharges, sulfuric acid reacts with the electrodes to produce electrons and ions that flow through an external circuit, producing electrical energy.

ESS policies mostly promote energy storage by providing incentives, soft loans, targets and a level playing field. Nevertheless, a relatively small number of countries around the world have implemented the ESS policies.

In the past decades, China has emerged as the world's largest emitter of greenhouse gases, with its energy sector accounting for approximately 70% of the country's carbon emissions (Fang et al., 2022). Just one year, in 2022, China's carbon dioxide emissions reached a staggering 10.55 billion metric tons, accounting for 30.69% of the global total.

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the "14th Five-Year Plan" period, the "Guidance" provided reassurance for the development of the industry.
