Approximately 16 states have adopted some form of energy storage policy, which broadly fall into the following categories: procurement targets, regulatory adaption, demonstration programs, financial incentives, and consumer protections. Below we give an overview of each of these energy storage policy categories.

Figure 2: Cumulative installed capacity of new energy storage projects commissioned in China (as of the end of June 2023) In the first half of 2023, China''s new energy storage continued to develop at a high speed, with 850 projects (including planning, under construction and commissioned projects), more than twice that of the same period last year.

The U.S. Department of Energy announced the creation of two new Energy Innovation Hubs led by DOE national laboratories across the country. One of the national hubs, the Energy Storage Research Alliance (ESRA), is led by Argonne National Laboratory and co-led by Berkeley Lab and Pacific Northwest National Laboratory.

Experts said developing energy storage is an important step in China's transition from fossil fuels to a renewable energy mix, while mitigating the impact of new energy's randomness, volatility, intermittence on the grid and managing power supply and demand. "Developing power storage is important for China to achieve green goals.

Battery and energy storage technologies are pivotal for U.S. national security, climate goals, and economic resilience.
