It is recognized that electric energy storage equipment or systems can be a single device providing all required functions or an assembly of components, each having limited functions. Components having limited functions shall be tested for those functions in accordance with this standard.

The Great Plains Institute (GPI) also conducted a national scan of jurisdictions for locally developed (i.e., sub-state) battery energy storage zoning standards.
