In addition to the economic imperative for a competitive EV and advanced battery sector, the Defense Department (DoD) requires reliable, secure, and advanced energy storage technologies to support critical missions carried out by joint forces, contingency bases, and at military installations.

The U.S. Department of Energy announced the creation of two new Energy Innovation Hubs led by DOE national laboratories across the country. One of the national hubs, the Energy Storage Research Alliance (ESRA), is led by Argonne National Laboratory and co-led by Berkeley Lab and Pacific Northwest National Laboratory.

MESA has developed and manages two specifications: MESA-DER (formerly MESA-ESS) and MESA-Device/SunSpec Energy Storage Model . MESA-DER addresses communication between a utility's control system and distributed energy resources (DERs), including ESSs. MESA-Device specifies standardized communications between components within the ESS.

Just four months after this incident, the National Fire Protection Association (NFPA) debuted the first edition of NFPA 855, Standard for the Installation of Stationary Energy Storage Systems. The release of NFPA 855 was a three-year effort to address fire safety concerns related to ESS installation and operation.
