However, many designers and installers, especially those new to energy storage systems, are unfamiliar with the fire and building codes pertaining to battery installations. Another code-making body is the National Fire Protection Association (NFPA). Some states adopt the NFPA 1 Fire Code rather than the IFC.

There are other requirements in IRC Section R328 that are not within the scope of this bulletin. 2021 IRC Section R328.2 states: "Energy storage systems (ESS) shall be listed and labeled in accordance with UL 9540." UL 9540-16 is the product safety standard for Energy Storage Systems and Equipment referenced in Chapter 44 of the 2021 IRC.

There have also been issues in the U.S. residential energy storage sector. For example, after five reported fires stemming from its RESU10 battery units, LG Chem issued product recalls in December of 2020 and again in August 2021. Just four months after this incident, the National Fire Protection Association (NFPA) debuted the first edition of NFPA 855, Standard for the Installation of Stationary Energy Storage Systems. The release of NFPA 855 was a three-year effort to address fire safety concerns related to ESS installation and operation.

Note that ESS units may not be installed in living areas or bedrooms. The maximum energy rating per ESS unit is 20 kWh. The maximum kWh capacity per location is also specified--80 kWh when located in garages, accessory structures, and outdoors and 40 kWh in utility closets or storage spaces.
