Natural gas-a colorless, odorless, gaseous hydrocarbon-may be stored in a number of different ways. It is most commonly held in inventory underground under pressure in three types of facilities. These underground facilities are depleted reservoirs in oil and/or natural gas fields, aquifers, and salt cavern formations.

The use of underground gas storage facilities in the natural gas industry is almost as old as the development of long distance transmission lines. The first high pressure transmission lines began operations in 1891 with successful construction of two parallel 120-mile, 8-inch diameter lines from fields in northern Indiana to Chicago.

below ground. The United States uses three main types of underground natural gas storage facilities: Depleted natural gas or oil fields--Most natural gas storage is in depleted natural gas or oil fields that are close to consuming areas.

Safety of Underground Natural Gas Storage Facilities: Interim Final Rule. On December 19, 2016, PHMSA published in the Federal Register an Interim Final Rule (IFR) that revises the Federal pipeline safety regulations to address critical safety issues related to downhole facilities, including wells, wellbore tubing, and casing, at underground natural gas storage (UNGS) facilities.

We use two metrics to assess working natural gas storage capacity. The first metric--demonstrated peak capacity--rose 3% by 124 billion cubic feet (Bcf) in 2023, reflecting the increased use of natural gas storage due to market conditions. The second metric--working gas design capacity--fell close to 0.0%, or 3 Bcf, in 2023.

Natural gas is stored underground primarily in three reservoir types: depleted oil and natural gas fields, salt formations and depleted aquifer s. Natural gas may also be stored above ground in refrigerated tanks as liquefied natural gas (LNG).
