

New energy storage development policy released

The country has vowed to realize the full market-oriented development of new energy storage by 2030, as part of efforts to boost renewable power consumption while ensuring stable operation of the electric grid system, a statement released by the National Development and Reform Commission and the National Energy Administration said.

The main goals of new energy storage development include: Full market development by 2030. 1) Strengthening planning guidance to encourage the diversification of energy storage; 2) Promoting technological progress to expand the energy storage industry system; 3) Improving the policy mechanism to create a healthy market environment;

The bidding volume of energy storage systems (including energy storage batteries and battery systems) was 33.8GWh, and the average bid price of two-hour energy storage systems (excluding users) was $\text{\$}1.33/\text{Wh}$, which was 14% lower than the average price level of last year and 25% lower than that of January this year.
