An energy company that pulled a plan to build a battery storage plant in Morro Bay is back with a new proposal -- and it's far more ambitious than the first go-round. Morro Bay Power Plant owner Vistra Energy had applied for a permit last year to build a 4-acre, 200-megawatt battery storage plant behind its mothballed power facility.

To promote the integration of new energy generation with new energy storage, offshore wind power projects, centralized photovoltaic power stations, and onshore centralized wind power projects must be equipped with new energy storage facilities that are no less than 10% of the installed capacity and have a duration of 1 hour.
