The Union Cabinet, presided over by Prime Minister Narendra Modi, has given the green light to the Battery Energy Storage Systems (BESS) Scheme. This scheme is designed to foster the development of BESS projects, totaling a remarkable 4,000 MWh by the year 2030-31, through a competitive bidding process.

The government's subsidy push has so far prompted an increasing number of private companies to invest in battery storage projects, including large-scale plants. With countries around the world pushing to accelerate their renewable deployments, it is more important than ever to maximize solar electricity generation.

The new scheme can cover between 20% to 65% of PV system costs, depending on the subsidy pot. For batteries, the first two subsidy pots will cover 100% of battery purchases and installation. The third and fourth subsidy pots will cover 90% of the battery costs.
