State & Federal Assistance. New York State offers a number of ways for families to make ends meet in the face of higher energy prices. Low-Income Home Energy Assistance Program, (LIHEAP): This federally funded program helps qualified persons pay their heating bills during times when they need assistance. Need is determined by your income and other factors.

The funding authorizes \$814.6 million in total energy storage funding, which breaks down to \$675 million for 1.5 GW of community and C& I energy storage incentives, \$100 ...

Guided by some of the nation's most aggressive climate and clean energy initiatives, New York is advancing a suite of efforts - including the New York Cap-and-Invest program (NYCI) and other complementary policies - to reduce greenhouse gas emissions 40 percent by 2030 and 85 percent by 2050 from 1990 levels.

The policy proposes to promote the large-scale application of energy storage, and support the integrated development of new energy sources such as photovoltaics and energy storage facilities. For new energy storage stations with an installed capacity of 1 MW and above, a subsidy of no more than 0.3 yuan/kWh will be given to investors based on ...

Energy Storage Roadmap. In June 2019, Governor Andrew M. Cuomo announced the state's plan to jump-start the development of energy storage in New York, calling for the deployment of 1.5 gigawatts (GW) by 2025. The New York State Public Service Commission (PSC) subsequently enhanced that goal by establishing a target of 3.0 GW by 2030.

The Roadmap proposed a comprehensive set of recommendations to expand New York's energy storage programs to cost-effectively unlock the rapid growth of renewable energy across the State and bolster grid reliability and customer resilience.
