1. UNDERSTANDING ENERGY STORAGE COMMISSIONING. The concept of energy storage commissioning revolves around the comprehensive verification and validation of system functionality prior to its integration into the broader energy infrastructure. This stage typically follows the installation of the system and precedes its operational usage.

Commissioning is a required process in the start-up of an energy storage system. This gives the owner assurance that the system performs as specified. A Commissioning Plan prepared and followed by the project team can enable a straightforward and timely process, ensuring safe and productive operation following handoff.

Plan early and often for energy storage safety; Safety is priority number one for solar-plus-storage systems, and planning should start well before installation. ... It may seem obvious, but field operators, project managers, commissioning engineers, and asset management professionals should proactively share lessons learned for optimal success ...
