

Peru pumped energy storage project bidding

Pumped Storage Projects (PSPs) or Pumped hydro are known as "the world's water battery" and is rugged, long-lived, mature and proven technology. Globally, Pumped storage accounts for over 95 per cent of installed energy storage capacity, well ahead of other storage technologies.

The recent decision of the government to introduce tariff based competitive bidding (TBCB) for pumped storage plants is diametrically opposite to what has been the government policy in the past as far as the hydro sector is concerned. Project financing (SEB6) The construction of a new pumped hydro project is subject to the availability of funds, either from the government, private sector investors or multiple financing sources, and it is a challenging and complex task (IHA, 2018b).

Among the drivers, pumped hydro storage as daily storage (TED2.1), under the utility-scale storage cluster, was the most important driver, with a global weight of 0.148. Pumped hydro's ability to generate revenue (SED1.1), under the energy arbitrage cluster, was the second most prominent driver, with a global weight of 0.096.

Pumped hydro storage has the potential to ensure the grid balancing and energy time-shifting of intermittent renewable energy sources, by supplying power when demands are high and storing it when generation is high.

According to the CEA, the project developers have indicated that they will fast-track the commissioning of the PSPs for completion by 2028. PSPs store energy in the form of gravitational potential energy in reservoir water and are the most established large-scale energy storage technology, accounting for approximately 90% of the world's installed storage capacity.

In a recent Energy-Storage.news Premium interview, Franck Bernard, the energy storage head of developer Gurin Energy said that the Japanese BESS market is ready for scale-up, with the company planning to begin building a 500MW/2,000MWh project in the country in 2026. Since Chile passed a major energy storage bill, gigawatts of energy storage co-located with solar PV are being built in the country. Earlier this year the country opened a public land bidding auction seeking 13GWh of standalone energy storage projects across four regions - Arica and Parinacota, Tarapaca, Antofagasta and Atacama.

According to the guidelines, governments may also use competitive bidding, tariff-based competitive bidding, or self-identified off-stream pumped storage projects.
