

# Policies related to energy storage

Recent Findings State activity related to energy storage has accelerated in recent years, and numerous policies have emerged. Generally, those policies take one of two approaches: facilitating operational experience with energy storage by ensuring its presence on the grid, or enabling future deployments by removing or reducing barriers.

3 &#0183; A long-term trajectory for Energy Storage Obligations (ESO) has also been notified by the Ministry of Power to ensure that sufficient storage capacity is available with obligated entities. As per the trajectory, the ESO shall gradually increase from 1% in FY 2023-24 to 4% by FY 2029-30, with an annual increase of 0.5%.

As states increasingly declare decarbonization goals, they will need to create new policies, rules and regulations that will enable the deployment of an unprecedented amount of energy storage, according to the Clean Energy States Alliance (CESA), which just released its States Energy Storage Policy: Best Practices for Decarbonization report.

The International Energy Agency (IEA) estimates that in the first quarter of 2020, 30% of the global electricity supply was provided by renewable energy . ESS policy has made a positive impact on transport storage by providing alternatives to fossil fuels such as battery, super-capacitor and fuel cells.

The purpose of Energy Storage Technologies (EST) is to manage energy by minimizing energy waste and improving energy efficiency in various processes [141]. During this process, secondary energy forms such as heat and electricity are stored, leading to a reduction in the consumption of primary energy forms like fossil fuels [ 142 ].
