Although the energy storage industry in Spain is focusing on battery storage, there is also a possibility to increase pumped storage capacity. However, there are various challenges associated with developing these projects in Spain, including social and environmental impacts, and the timelines associated with such projects.

In 2015, two (2) new stations for fleets were opened i.e PTSC City Gate, Port of Spain and NGC Warehouse Pt Lisas. In 2016, seven (7) new public stations are listed to be opened. They are: Starlite Diego Martin, St Christopher's Wrightson Rd, Ramco Orange Grove, O'Meara Arima, Tumpuna Rd. Arima, Santa Flora and Harkness Mc Bean, Couva.

Global energy storage capacity was estimated to have reached 36,735MW by the end of 2022 and is forecasted to grow to 353,880MW by 2030. Spain had 88MW of capacity in 2022 and this is expected to rise to 2,500MW by 2030.
