

This port is the 5th busiest port in Europe and is an important seaport of the region. It primarily deals with container ships and other general cargo vessels.. Managed by the Valencia Port Authority (VPA), it is the largest container port in Spain (5.4 million TEU as of 2019) and the second largest in the Mediterranean region (behind the Port of Piraeus, Greece).

1. Port Terminals. Ports are mainly multifunctional entities, but this characteristic is often the result of the combined activities of a number of specialized terminals, each dealing with specific goods and commodities such as containers, grain, oil, or iron ore. Thus, a port is a combination of terminal facilities, each developed to fulfill a specific function and sometimes serving a single ...

Finally, peak sharing is another way of managing electrical demand, where ports use a generator or the energy stored in batteries to power a portion of the terminal's electrical load in peaks (van Duin et al., 2018). Further, batteries of AGVs can be used as storage to compensate for sudden peaks of electrical STS or RTG cranes.

Overall, each dry container across the globe consumes around 10.4 Litre diesel equivalent (Spengler and Wilmsmeier, 2019). Mart&#237;nez-Moya et al.
