The benefits are gained from energy arbitrage, peaking power generation, energy loss reduction, system upgrade deferral, emission reduction and VAR support. A cost-benefit analysis is also conducted to identify the optimal Net Present Value (NPV), Discounted Payback Period (DPP) and Benefit-Cost ratio (BCR).
