In order to develop a dedicated safety analysis method for hydrogen energy storage system in power industry, the risk analysis for the power-to-gas-to-power& heat facility was made.

The fire codes require battery energy storage systems to be certified to UL 9540, Energy Storage Systems and Equipment. Each major component - battery, power conversion system, and energy storage management system - must be certified to its own UL standard, and UL 9540 validates the proper integration of the complete system.
