Scotland is the home to two offshore wind demonstration projects: The two turbine, 10MW Beatrice Demonstrator Project located in the Moray Firth, and the single turbine, 7MW Fife Energy Park Offshore Demonstration Wind Turbine in the Firth of Forth. There are also several other commercial-scale and demonstration projects in the planning stages.

Offshore wind energy remains a largely untapped resource globally, but Scotland's ScotWind leasing round is likely to unleash a high volume of innovative projects and increase generation capacity. Currently, 8.8GW is generated by onshore wind in Scotland, with 2.1GW from offshore wind.

The energy storage system will be used for the UK's biggest onshore wind farm, developed by Scottish Power Renewables near Glasgow. Ingeteam will also supply the control system, the power converters and the ion-lithium batteries. The storage capacity will be 50 million Watt-hours, equivalent to the average hourly power consumption of 150,000 ...
