

Shared energy storage project subsidy policy

Background. The Long Duration Energy Storage (LDES) program has been allocated over \$270 million to invest in demonstration and deployment of non-lithium-ion long duration energy storage technologies across California, paving the way for opportunities to foster a diverse portfolio of energy storage technologies that will contribute to a safe and reliable ...

Most cities do not have high profitability for energy storage to participate in peaking auxiliary services and urgently require policy subsidies. Specifically, under certain policy conditions, a subsidy of at least 0.0246 USD/kWh is necessary to motivate investors to invest effectively.

Various regions have introduced investment subsidies for energy storage projects. For example, in Zhejiang Province, for photovoltaic power projects with an installed capacity greater than 1000 kW, there was a one-time subsidy of 0.3 yuan/W for the installed capacity, as well as a one-time subsidy of 0.3 yuan/W for energy storage capacity.

According to statistics from the CNESA global energy storage project database, by the end of 2019, accumulated operational electrical energy storage project capacity (including physical energy storage, electrochemical energy storage, and molten salt thermal storage) in China totaled 32.3 GW. Of this total, new operational capacity exceeded 1 GW.

For projects such as user-side energy storage, distributed photovoltaic+storage, and charging & swapping integration projects that have been registered and put into operation in the district, a subsidy of 200 yuan/kWh will be granted according to the installed capacity if the energy storage duration is not less than 2 hours.

For new energy storage stations with an installed capacity of 1 MW and above, a subsidy of no more than 0.3 yuan/kWh will be given to investors based on the amount of discharge electricity from the next month after grid connection and operation, and the subsidy will not last for more than 2 years.
