

A new ship powered only by lithium-ion batteries is coming to Japan's coastline. ... The 3.5-megawatt-hour (MWh) energy storage system is about the size of 40 Tesla Model S battery packs.

The price of a lithium-ion battery pack used to power an electric vehicle has plunged 89% in the last decade, from \$1,100 per kWh to \$137 per kWh. Marine batteries still cost significantly more, ranging between \$800-\$1,000 per kWh for retrofits to \$500 per kWh for newbuilds. DNV expects the cost of batteries to be reduced by 56% by 2025.

Lithium-ion batteries have been recently installed onboard smaller scale ferries and passenger vessels either as the primary energy source, or then as a hybrid solution. Various lithium-ion battery chemistries are available, with sources pointing at lithium nickel manganese cobalt oxide as the most feasible solution for ships.

The number of battery-powered vessels, backed by such remarkable research, is growing rapidly around the world.
