Operating Limitations: Energy storage resources may be subject to operational constraints that do not affect traditional generation projects. For example, certain battery technologies will degrade more quickly if the state of charge is not actively managed within a certain range.

On December 22nd, Tesla announced the signing of a land transfer agreement for its Shanghai Energy Storage Super Factory project.
