In the Sustainable Africa scenario, South African energy exports will decline to about US\$2.7 billion in 2050 (compared to the Current Path forecast of US\$12.7 billion), and energy imports will increase by US\$29.4 billion. The associated energy transition would be huge but outweighed by the benefits to its economy and the health of its citizens.

Analyst Corentin Baschet, of Europe-based energy storage consultancy Clean Horizon, which worked with some of the Preferred Bid winners in partnership with South African renewable energy consultancy Harmattan Renewables, told Energy-Storage.news that "South Africa is facing an urgent need for additional capacity to prevent load shedding".

The literature review and case studies revealed that a policy environment that recognises and signals the strategic value of energy storage can direct and enable development and investment in the sector. South Africa's policy environment, represented by the IRP 2019, recognises ESS but only as a generation asset.

South Africa has an opportunity to deploy energy storage technology to contribute meaningfully to a more resilient, stable, and sustainable electricity system. The country's potential to successfully integrate energy storage was specifically noted by the IFC / ESMP study focused on emerging markets.

About applying for an export permit. To export certain goods out of South Africa, you must have a permit ensuring that you comply with applicable export control measures. The export of some goods may be restricted to support beneficiation strategies or to assist local manufacturers to obtain raw materials before they are exported.

South Africa's existing energy laws and regulatory measures were largely formulated to regulate and support a fossil fuel-based electricity industry, without explicitly considering or promoting renewable energy and BESS applications.
