The future role of stationary electricity storage is perceived as highly uncertain. One reason is that most studies into the future cost of storage technologies focus on investment cost. An appropriate cost assessment must be based on the application-specific lifetime cost of storing electricity.

Power systems in the future are expected to be characterized by an increasing penetration of renewable energy sources systems. Assuming N = 365 charging/discharging events, a 10-year useful life of the energy storage component, a 5% cost of capital, a 5% round-trip efficiency loss, and a battery storage capacity degradation rate of 1% annually, the corresponding levelized cost figures are LCOEC = 0.067 per kWh and LCOPC = 0.206 per kW for 2019.
