However, the intermittent nature of renewable energy requires the support of energy storage systems (ESS) to provide ancillary services and save excess energy for use at a later time. ESS policies have been proposed in some countries to support the renewable energy integration and grid stability.

The recently published National Electricity Storage Strategy aims to provide further incentives for the storage of electricity from renewable energy sources. 5.3 What are the main sources of financing for the development of energy storage projects in your jurisdiction? ESS policies mostly promote energy storage by providing incentives, soft loans, targets and a level playing field. Nevertheless, a relatively small number of countries around the world have implemented the ESS policies.

Impact: National governments are beginning to realize that energy storage is essential and the storage technologies are going to play an important role in the integration and expansion of renewables across the globe. Incentives: The key incentives on Energy Storage offered by some of the governments across European countries include:

InfoLink estimates that under an ideal scenario, China would have seen 1.4 GW of demand for solar-plus-storage in 2021, and this year would see 3.9 GW - a 200% increase based on policy frameworks and installed PV capacity. In reality, only 500 MW of energy storage systems (ESS) were integrated with PV in 2021.
