From June, system operators and distribution companies will be able to apply for subsidies to build energy storage facilities by the summer of 2025 at the latest, the Ministry said. Comprehensive upgrades to our country's transmission and distribution infrastructure, and switching from heavy and diesel fuels to solar power and natural gas, will create new efficiencies and reduce the price of electricity in The Bahamas.
