If China accelerates the transition to cleaner energy, as part of a strategy for peaking greenhouse gas emissions during the 14th Five-Year Plan (i.e. by 2025), it could change the world"s commitment to the environment and could contribute greatly to the success of both the 15th session of the Conference of the Parties to the Convention on ...

The "14th Five-Year" Development Plan for Emerging Businesses proposes that during the "14th Five-Year Plan" period, in promoting the realization of the carbon peaking and carbon neutrality goals and building a new power system based on new energy resources, the development of emerging businesses will usher in an important period of strategizing, ...

The plan specified development goals for new energy storage in China, by 2025, new energy storage technologies will step into a large-scale development period and meet the conditions for large-scale commercial applications.

In short, the five year plan's outline sets a 18% reduction target for "CO2 intensity" and 13.5% reduction target for "energy intensity" from 2021 to 2025. For the first time, it also refers to China's longer-term climate goals within a five year plan and introduces the idea of a "CO2 emissions cap", though it does not go so far ...

By July 2022, the Chinese energy authorities have issued three major policies for the 14th Five-Year (2021-2025) and mid- to long-term (2035) development of the energy storage sector including pumped-hydro storage, new-type storage and hydrogen energy. Here please find a short summary of them.

In January 2022, "the 14th Five-Year Plan for Modern Energy System" proposed accelerating the large-scale application of energy storage technologies. Optimize the layout of grid-side energy storage. Play the multiple roles of energy storage, such as absorbing new energy and enhancing grid stability.

The first stage (during China's 13th Five-Year Plan period) realizes the energy storage from the R& D demonstration stage to the initial stage of commercialization; the second stage (during China's 14th Five-Year Plan period) realizes the energy storage from the initial stage of commercialization to the stage of large-scale development.

The 14th "Modern Energy" Five-Year Plan, the overarching FYP for different energy sectors released in February, has crystalized these strategy changes. Energy security has become the No.1 priority of the top authority in the 14th FYP period--it is again a top priority after a decade of sufficient energy supply (and oversupply)

Recently, Qinghai deliberated and passed the proposal on formulating the fourteenth five year plan for national economic and social development and the long-term goal for the year 2035.
