The City's electric utility, Silicon Valley Power, is well on its way to meeting the State's goals for renewable energy. SVP commits to only procure new energy sources that are renewable and/or greenhouse gas-free (GHG) to the city: 50% renewable energy by 2026; 60% renewable energy by 2030; GHG free energy supply by 2045

Silicon Valley Power offers grants up to \$100,000 to qualifying nonprofit organizations for the installation of a solar photovoltaic (PV) system at their facility. Grants may cover up to 100 percent of the system cost. Up to ten percent of the grant funds may be used on qualifying building repairs or infrastructure to make the site PV ready.

Silicon Valley Power (SVP) has selected Ameresco, a Massachusetts-based renewable energy developer, to build a 50MW/200 megawatt-hour (MWh) battery energy storage system (BESS) in Santa Clara, California, US. The BESS project, known as Kifer Energy Storage, will offer additional local area capacity with a reliable and flexible electrical system.
