



# Virginia energy storage procurement policy

Renewables, in particular, will be boosted by a 5.2-GW target for new offshore wind power capacity and 16.1 GW for onshore wind and solar photovoltaic (PV) procurement that is "in the public interest." Separately, the state's largest energy companies will be required to build or acquire over 3.1 GW of energy storage capacity.

All of the states with a storage policy in place have a renewable portfolio standard or a nonbinding renewable energy goal. Regulatory changes can broaden competitive access to storage such as by updating resource planning requirements or permitting storage through rate proceedings.

Virginia passed energy storage procurement targets in 2020, setting a requirement of 3.1 GW of storage capacity by 2035 from the state's two Investor Owned Utilities. Ten percent of the procurement must be deployed behind the meter, meaning on-site storage at a home or business, and 35 percent of the overall target must be owned by non-utilities.
