The Institute Electrochemical Energy Storage focuses on fundamental aspects of novel battery concepts like sulfur cathodes and lithiated silicon anodes. The aim is to understand the fundamental mechanisms that lead to their marked capacity fading.

Localities have reiterated the central government's goal of developing an integrated format of "new energy + storage" (such as "solar + storage"), with a required energy storage allocation rate of between 10% and 20%. A total of 93 projects were submitted into the auction, with 12 winners, 3 runner-ups and 78 projects which were excluded from the final list. Projects bid in with a desired annual aid amount, with a weighted average of the winning projects of EUR49,748 per MW per year. This is less than half of the upper limit that projects could bid in at, of EUR115,000.

As the cost of battery energy storage continues to decline, we are likely to see the emergence of merchant energy storage operators. These entities will seek to maximize their operating profits through strategic bidding in the day-ahead electricity market. One important parameter in any storage bidding strategy is the state-of-charge at the end of the trading day. ...
