

# What is a second-life energy storage battery

During that point, batteries can still handle a good amount of charge and discharge and thus, there is a second life of a battery which can be deployed at static energy storage applications such as grid storage, renewable energy power plants, ancillary service market, residential usage, data center back-up applications, etc.

The second-life battery storage system in Herdecke is one of ten battery projects RWE is implementing in the US, Germany and Ireland. In parallel, the company is working on innovative projects such as redox flow batteries or battery storage systems with a virtual connection to hydropower stations.

Second life batteries are ones that have reached the end of their "automotive" life but still have a residual capacity of about 70-80%. This means they can be used in stationary systems, in combination with renewable energy generation, such as wind and solar, and/or to supply services to the electricity network.

Potential applications for second-life batteries range from use in private households to industrial solutions to network services. Here are some examples Home energy storage for private households, e.g. to optimize energy usage. Commercial and industrial storage applications, e.g. to cap peak loads or to optimize energy usage.

A second-life battery, also known as the repurposed battery, is a used battery that has reached the end of its useful life in electric vehicles (EVs). However, these batteries still have a significant amount of energy storage capacity.

The adoption of electric vehicles (EVs) is increasing due to governmental policies focused on curbing climate change. EV batteries are retired when they are no longer suitable for energy-intensive EV operations. A large number of EV batteries are expected to be retired in the next 5-10 years. These retired batteries have 70-80% average capacity left. ...

In 2020, Connected Energy conducted a collaboration with Groupe Renault, using the retired batteries from Renault Kangoo Z.E. to their second-life battery energy storage system E-STOR [12]. In China, the development of B2U is also rapid.
