

Will Europe promote air energy storage projects

Energy storage - what incentives may be provided In 2015 the European Parliament published the paper "Energy Storage: Which Market Designs and Regulatory Incentives are Needed?"¹, identifying the most important policy recommendations aimed to promote wider use of the energy storage systems. These recommendations include among others: 1.

Now, the EU must do the same for energy storage, particularly LDES, to ensure delivery of these renewables reliably and affordably. The performance of electrochemical energy storage technology will be further improved, and the system cost will be reduced by more than 30%.
