Incentivizing investment in rooftop solar through feed-in tariffs Households and businesses can now install rooftop solar solutions and connect their energy to the grid, as the government has recognized. To incentivize this project, a "feed-in tariff" will be developed by Eskom for all commercial and residential rooftop solar installations.
